17 **ORDER APPROVING THE SALE OF DEBTOR'S INTERESTS**  
18 **IN IP ADDRESSES FREE AND CLEAR OF LIENS AND INTERESTS**

19 The duly noticed Motion by Marc Del Piero, Trustee, for an order approving the sale of the  
20 Debtor's property consisting of the exclusive right to use 65,636 legacy IPv4 addresses registered  
21 to the Debtor ( the "Assets"), to Peak 10, Inc. (the "Purchaser"), "as-is," "where-is" for the sum of  
22 \$590,000.00; seeking a declaration that the Purchaser is in good faith and entitled to the  
23 protections of Bankruptcy Code § 363(m); and further requesting that any applicable stay under  
24 Rule 6004 (h), Fed. Rules of Bankruptcy Procedure be waived, has been presented to this Court,  
25 due notice thereof having been given, no objection thereto having been made, and the Court  
26 having reviewed the pleadings filed in support of the Application, and having concluded that the  
27 sale is in the best interest of the creditors of the estate, and that the Purchaser is entitled to the  
28 protection sought, now, therefore:

1 IT IS HEREBY ORDERED that the sale to the Purchaser of all of the Debtor's and  
2 bankruptcy estate's interests in the Assets for the amount of \$590,000.00 is approved; and

3 IT IS FURTHER ORDERED that the Purchaser is in good faith and entitled to the  
4 protections of Bankruptcy Code § 363(m); and

5 IT IS FURTHER ORDERED that any applicable stay under Rule 6004 (h), Fed. Rules of  
6 Bcy. Procedure is waived; and

7 IT IS FURTHER ORDERED that the sale is on a "as is, where is" basis; and

8 IT IS FURTHER ORDERED that the purchase and sale agreement and related documents  
9 may be modified, amended or supplemented by the parties without further order of the court,  
10 provided that such modification, amendment or supplement does not have a material adverse  
11 affect on the estate; and

12 IT IS FURTHER ORDERED that the sale is free and clear of the interests of all entities  
13 receiving notice of the sale; except that nothing in this Order is intended to relieve or exempt the  
14 Purchaser from compliance with the policies of the American Registry of Internet Numbers  
15 ("ARIN"); and

16 IT IS FURTHER ORDERED that the Purchaser shall assume responsibility for such  
17 arrangements as may be required by ARIN to complete the transfer of the registration of the  
18 Assets upon approval of the sale, and that upon compliance with such ARIN policies, the transfer  
19 of the registration rights shall be effectuated; and

20 IT IS FURTHER ORDERED that nothing in this Order shall be construed to require ARIN  
21 to take any action in violation of its policies; and

22 IT IS FURTHER ORDERED that this Court retains jurisdiction to implement the sale or  
23 enforce the sale order; and

24 IT IS FURTHER ORDERED that the Trustee is authorized to pay to the broker, IP4Group,  
25 Inc., a commission of 17.5% from the proceeds of sale pursuant to the approved terms of  
26 employment (ECF Nos. 55 and 57); and

27 IT IS FURTHER ORDERED that the Trustee is authorized to sign all documents and  
28 perform such acts as are reasonably necessary to transfer all of the estate's rights and interests in

1 the Assets to the Purchaser.
